




Netherlands Food Partnership

Ghanaian Urban Food Environments



- Theme derived from F&BKP/APF nutrition & food systems work;
- Underexplored but huge potential to change food systems and improve food & nutrition security;
- Building further on measuring food environments focus by applying a practical approach for effective interventions;
- Ghana as a starting case Frontrunner research and policy wise and building further on existing NL-Ghanaian ties;
- Content (direction, leverage points etc.) to be developed with relevant stakeholders and exact city to be defined jointly;
- Working towards one core coalition with sub coalitions?

The process so far in 2020



June-July: Literature mapping and inventory of actors working on this topic.

August-September: Exploration talks with experts and practitioners.

-> Potential coalition members confirmed that support to form a coalition is critical and expressed a big need for multi-stakeholder partnerships because various great initiatives often work isolated.

September: Drafted and shared first version of background document, serving as a starting point for coalition work.

October: 1st inventory meeting with potential coalition members & meeting report and next steps composed.

(Urban) food policy

- Contribute to food policy direction and implementation
- Strengthen advocacy
- Further develop and implement clear national product nutrition standards
- Promote healthy food consumption

Public-private cooperation

- Encourage private-public initiatives and action
- Engage authorities and regulators
- Support nexus PPPs (Water Food Energy)
- Encourage private sector to
 take the lead

Coherent and integral approach

- Increase coherence across actors and processes in (city region) food systems
- Shorten value chains farm to fork
- Facilitate more sustainability, circularity, resilience and value in food environment and related chains

Urban planning

- Link city planners and architects to food environments
- Address food system
 infrastructure

Knowledge work

- Disseminate information
- Develop strategy for knowledge
 - implementation
- Generate more evidence for advocacy
 Capacity building

Leverage points seen by potential coalition partners



Linking Dutch & Ghanaian actors

- Identify relevant stakeholders
- Facilitate participation of Dutch and Ghanaian companies and local policy makers
- Deliver practical support on the ground to bring different stakeholders together

Advocacy

- For adaption and adoption of national nutrient profiling criteria / guidelines
- Against advertising unhealthy (processed) foods
- For healthier food intake by urban consumers

Knowledge work: sharing, generating, disseminating

- Study what has been done and worked (elsewhere)
- Develop joint research
- Evidence generation and synthesis
- Contributing specific content

Implementation / support

- Support in development of strategy for financial independence / sustainability
- Support in implementation at community level
 Supply feed
- Supply food

Urban planning

- Work on food accessibility and urban infrastructu
- Address architectural design issues
- Implement cross disciplinary approach

Next steps by NFP



- Continue introductory and follow-up calls with potential coalition partners.
- Draft and share first proposal for coalition shape, leverage points, startup activities and preliminary action plan for 2021.
- Relevant coalition knowledge products to be developed, as suggested by potential partners include:
 - Overview paper of relevant knowledge and leverage points
 - Further mapping of of institutions and individuals who can make a difference on the ground
 - Inventory of lessons of (similar) programmes that worked in Ghana context >> how translate knowledge to policy and into action?
 - Development of a plan to involve and link stakeholders in the generation/mapping of more data and evidence for concrete actions and policy implementation.
- Possible next (sub)coalition meeting beginning 2021.
